

WEBSITE: The Finance Committee reviews and makes recommendations for expenditure of funds and budget policies, assesses the efficiency of the grantee in rapidly allocating funds to the areas of greatest need, and conducts other activities as assigned by the Planning Council. 

- Intermediary between HIPC and recipient understanding the financial details to relay to the council so they can make informed decisions with adequate information
- Through questions, comments, and suggestions, the finance committee helps the recipient reformat information so it's digestible for not only the committee itself, but also the full council
- First eyes on budget
- Facilitate the allocations process
