# 4Q Spending Summary

Reconciliation of the total invoices forwarded to the Recipient (DHH) for processing through March 31, 2025, indicated four percent (4%percent/\$808,393) underspending of our total overall award (includes MAI funds). It should be noted final expenditures are still being processed. Amid the Federal Financial Report (FFR), the Recipient is aware these figures may have a differential of less than \$15,000.

Services reported as overspent were made whole through reallocation. The Recipient conducts quarterly reconciliations to determine need to reallocate funding.

Vacancies and cumbersome hiring practices in Systemwide Allocations typically drive underspending. The Recipient diligently ensures this underspending is reallocated to direct service categories.
